Reimagine Destinations Program Overview

The Reimagine Destinations program supports Colorado tourism destinations to advance tourism projects that foster long-term industry resilience. Up to 24 Colorado tourism destinations will be selected to participate in the Reimagine Destinations programs.

Awarded destinations will receive:

- a destination assessment
- a full-day community visioning and action planning workshop
- 100 hours of free consulting to implement priority tactics that are identified during the workshop
- \$20,000 in Colorado Tourism Office direct marketing support (no match required)

Program Timeline:

- May 3, 2022: program applications open
- June 7, 2022 at 4 p.m. (MDT): application deadline
- July 7, 2022: destinations are awarded programming
- August 2022: work on the destination assessments begin
- September 2022 - December 2022: workshops are hosted
- November 2022 - January 2023: 100 hours of free consulting begins

Selection Process

A panel of industry partners and Colorado Tourism office staff reviews applications and recommends awards based on an understanding of destination priorities and capacity to participate. A representative from the Colorado Tourism Office will respond to your application within one month of the application deadline.

Section Two: DESTINATION DESCRIPTION

The CTO requires that each applying destination identifies one or more local tourism champions to serve as the lead applicant for the application. As a condition of selection to participate in a program, these local tourism champions are responsible for approximately 50 hours of work between July 2022 to June 2023. Roles and responsibilities of the lead applicant include:

- participation in preparation and planning, including providing current data and information on barriers and opportunities for advancing tourism within their destination
- outreach and coordination of tourism stakeholders within their destination
- event planning support for the full-day workshop, such as venue and catering logistics
- ongoing leadership within their destination to implement a destination resilience action plan

When appropriate, lead applicants for destinations should consider additional tourism leadership organizations from adjacent destinations to collaborate with.

Destinations that include gateway communities to public land units should have land management representation on the core team, or have their written support to include those public land units in the program.
