# Innovative Housing Incentive Program (IHIP) Grant Application Guide

## About the program

The Innovative Housing Incentive Program (IHIP), which emerged as a recommendation from the 2021 interim Affordable Housing Transformational Task Force, was introduced to the Colorado General Assembly as HB22-1282 with bipartisan sponsorship in March 2022 and signed into law by Governor Polis in May. The program was designed to help address the state's critical lack of affordable and attainable housing by supporting innovative housing manufacturing businesses across the state through grants, loans, and cash incentives. The program was initiated with \$40 million in state funding and no sunset date.

The program includes three funding mechanisms for innovative housing manufacturers: a working capital grant, a per-unit cash incentive, and a factory loan. The working capital grant will partially reimburse innovative housing businesses' operating expenses. The per-unit cash incentive will reward manufacturers who build affordable and sustainable homes with a cash award for every unit built and installed in Colorado. Finally, the factory loan program will help finance the construction of new innovative housing manufacturing facilities or expanding existing facilities across the state. Each mechanism will be described in greater detail below.

The working capital grant and per-unit cash incentive have been merged into one application process. This guide covers the application process for these two funding mechanisms.

#### Eligibility and application process

The statute provides some parameters for eligibility, and otherwise allows OEDIT to determine which businesses are considered innovative and eligible for funding. Colorado-based manufacturers with under 500 employees that produce prefabricated, modular, panelized, 3D-printed, tiny, or kit homes are eligible for the incentive. To be eligible, the homes must be built for installation on permanent foundations. Businesses will also be required to submit a Certificate of Good Standing from the Colorado Secretary of State, and must have produced at least one prototype home in Colorado. These basic eligibility requirements will be covered by the IHIP Precertification application.

Upon having the precertification application approved, each eligible business will be invited to submit a full application. This application will include a more thorough description of the business, its products and manufacturing process, forecasted production, and its financial performance. OEDIT will review and summarize applications for an interagency review panel. As part of the review process, the applicant will present to that review panel and host an OEDIT representative for a site visit. OEDIT and the interagency panel will then decide whether to award the grant and will work with the applicant and OEDIT's procurement department to establish a two- to three-year contract, involving monthly updates and award disbursements.


## Required materials

Please have the following documents ready to upload to the application portal:


- Certificate of Good Standing from the Colorado Secretary of State
- Proof of business organization
- Balance sheets from the last three years, or since incorporation
- Year-end income statements or income tax filings from the last three years, or since incorporation
- Cash flow statements from the last three years, or since incorporation
- Any other documents (one-pagers, renderings, etc.) that will help OEDIT and the review panel understand your business better

### Precertification step-by-step application guide

- 1) If you do not already have an account on the <u>OEDIT portal</u>, please create one. It may take up to 48 hours for your account to be approved by a system administrator. While you wait for approval, you can begin gathering the documents listed above.
- 2) Once your account is set up, log into the OEDIT portal.
- 3) From the OEDIT home page, select the Innovative Housing Incentive Program.



4) Under "Apply for opportunities," click the "Apply" button next for the IHIP Precertification application.



- 5) Proceed to the eligibility questions, answering the five Yes/No questions and the one written response.
- 6) Click the "Next" button to advance and review your answers, then click "submit."
- 7) You will receive an automatic email confirming that your application was submitted.
- 8) Within three business days, your application will be reviewed and approved or denied. While you wait, it is another good opportunity to gather the required documents listed above.
- 9) If your precertification is approved, you will receive an email with instructions to log into the portal to complete a full application.

#### Full grant application step-by-step guide

- 10) To complete the full application, again log into the OEDIT application portal and click on Innovative Housing Incentive Program from the home page.
- 11) Select the IHIP Grant Application, which will be in draft and editable by clicking the blue edit icon.



- 12) The application has three sections: General Business Information, Additional Information, and File Upload. Please complete each section. You may save and exit your application at any point in the process and return to it later, as this application will take considerably longer than the precertification. You may also type out application answers offline and then paste them into the actual application. You can view the application questions and character limits at the end of this guide.
- 13) When you get to the File Upload section, click "Choose file" to select the file, then click "Upload." You may upload multiple files where it is relevant or required. The operating expense and unit production forecast spreadsheet and attestation forms are available for download within the application.
- 14) If you have properly answered all questions and uploaded all required files, you will be able to proceed to the Review & Status section. From there, you may submit the application.

- 15) Once the application is submitted, OEDIT will begin the review process described above. Applicants can expect this process to take approximately one month.
